2009 Galapagos Expedition Agreement

Welcome to NYYC 2009 Galapagos Expedition!

Start Date: Friday, 3 April 2009, in Guayaquil, Ecuador

End Date: Sunday, 12 April 2009, in Guayaquil, Ecuador

Ten days and nine nights in Ecuador, including seven nights in the Galapagos aboard the ship "National Geographic Polaris" owned by Lindblad Expeditions. The price includes domestic roundtrip airfare from Guayaquil-Galapagos-Guayaquil; twice-daily landings and excursions ashore; use of sports and other equipment; the services of a Lindblad Expedition Leader, Naturalists and expert National Park Guides; and two nights accommodation in Guayaquil.

Excluded are the cost of international airfare to/from Guayaquil; alcoholic beverages; personal expenses; shipboard gratuities of \$14-16 per person per night; and **mandatory** NYYC MedJet Assist medical evacuation and repatriation insurance for each participant.

Financial Commitments:

- 1) Non-refundable deposit of \$1,000 per person / \$2,000 per double cabin is payable by check within two weeks of receiving your reservation and should accompany this signed agreement mailed to the Sailing Office.
- 2) 2nd payment of 40% of cabin ticket price due June 30, 2008 by check.
- 3) Final payment due September 30, 2008 by check (fuel surcharge may apply).

Cancellation Policy

- Once members have signed up for the cabin, they are responsible for the entire cost of the cabin unless the Club can resell it.
- Applications for Travel Insurance can be requested through the Club.

Method of Payment:

- **Payments are due by check only.** This amount cannot be charged to your New York Yacht Club member account.

- The Second and Final payments may be made in advance by check.

Medical and Other Information:

This is an expedition, which can be strenuous and is far from medical aid. Members and all participants agree to arrange Med Jet Assist medical evacuation insurance for this expedition through the Sailing Office. The ship has a qualified Ecuadorian physician aboard, but each participant must provide for his/her own individual personal medications and needs. 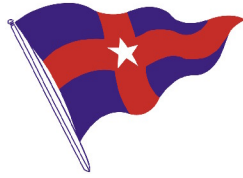
