<u>Charter Boat Agreement</u> – Attached please find the Bareboat Charter Party Agreement for the 2017 Invitational Cup. Please note that the signed agreement and charter fee in the amount of USD\$20,000 are both due no later than <u>April 1, 2017</u>, and the USD\$1,000 insurance fee is due no later than August 1, 2017. Payment is by check or wire transfer. Payment instructions are included on the accompanying page. The Charter Agreement shall be returned to the attention of Beth Duggan via email, fax or post.

Once we have received the signed agreement and fee, a charter boat will be confirmed for your club for the Invitational Cup. Later in the year we will conduct a random drawing to assign each charter boat to a specific club. Following that drawing, you will be advised of the name and hull number of your club's charter boat. Please note that boats which have been privately chartered prior to the Regatta may be assigned to the same teams at the discretion of the Organizing Authority.

For those clubs bringing their own Swan 42 to the Invitational Cup, including those that have a seasonal charter, we ask that you, also, please complete the attached Agreement and return it by April 1. All yachts **must** be chartered through the NYYC Regatta Association for the period of September 9-16 to ensure that all are covered under NYYC's insurance policy for the regatta. There will be no exceptions.

Thank you for your attention to these matters. We look forward to hearing from you at your earliest convenience.
